



**RESOLUTION
OF THE COUNCIL
OF VILNIUS UNIVERSITY**

**ON THE APPROVAL TO EXPAND THE BOUNDARIES OF VILNIUS UNIVERSITY
TERRITORY BY PURCHASING REAL ESTATE with land parcels in Merkio g. 13,
Puvočiai Village, Marcinkonys Eldership, Varėna District Municipality and Kairėnų g. 65,
Vilnius**

In accordance with Articles 3(3) and 38(1)(9) of the Statute of Vilnius University and Items 12(1) and 13 of the Description of the Procedure for the Use of Funds and the Management, Use and Disposal of Assets of Vilnius University, approved by Resolution of the Council of Vilnius University No. T-2017-2-10 of 7 April 2017 “On the Approval of the Description of the Procedure for the Use of Funds and the Management, Use and Disposal of Assets of Vilnius University”, taking into account Article 88(1)(5) of the Republic of Lithuania Law on Higher Education and Research, Proposal from the Rector of Vilnius University No. RTK-36 of 21 June 2023 “On the Approval to Expand the Boundaries of Vilnius University Territory by Purchasing Real Estate With Land Parcels Located in Merkio g. 13, Puvočiai Village, Marcinkonys Eldership, Varėna District Municipality and Kairėnų g. 65, Vilnius”, and Resolution of the Senate of Vilnius University No. SPN-29 of 20 June 2023 “On the Approval to Expand the Boundaries of Vilnius University Territory by Purchasing Real Estate With Land Parcels Located in Merkio g. 13, Puvočiai Village, Marcinkonys Eldership, Varėna District Municipality and Kairėnų g. 65, Vilnius”, the Council of Vilnius University hereby d e c i d e s:

1. To approve the expansion of the boundaries of Vilnius University territory by purchasing the following:

1.1. a building – barn, unique number 4400-2424-9449, building area 21 sq. m., designation – auxiliary farm building; and a land parcel, unique number 3828-0001-0245, total area 0.0307 ha, designation – other, located in Merkio g. 13, Puvočiai Village, Marcinkonys Eldership, Varėna District Municipality;

2.1. 62/100 of a building – residential building, unique number 1094-0140-0017, total area 136.79 sq. m., designation – residential (single-apartment buildings) and a land parcel, unique number 0101-0013-0013, total area 0.1096 ha, designation – other, located in Kairėnų g. 65, Vilnius.

2. To establish that the purchase price of the property indicated in Item 1 of this Resolution cannot exceed the value of property established in accordance with the Republic of Lithuania Law on the Bases of Property and Business Valuation by more than 20 per cent.
