



**RESOLUTION
OF THE SENATE
OF VILNIUS UNIVERSITY**

**ON THE SUBMISSION OF RESEARCH PAPERS TO THE 2023 COMPETITIONS FOR
THE NOMINAL PRIZES OF THE LITHUANIAN ACADEMY OF SCIENCES**

In accordance with Article 33(1)(32) of the Statute of Vilnius University, Item 5 of the Regulations of the Competitions for the Nominal Prizes Organised by the Lithuanian Academy of Sciences, approved by Resolution of the Presidium of the Lithuanian Academy of Sciences No. 28 of 28 September 2010 (as subsequently amended), and taking into account the motives laid down in the minutes of the e-meeting of the Council of the Faculty of Chemistry and Geosciences of Vilnius University of 11 November 2023 (Minutes No. 610000-TP-1), minutes of the meeting of the Council of the Faculty of Economics and Business Administration of Vilnius University of 14 November 2023 (Minutes No. (1.2E) 210000-TP-9), and minutes of the meeting of the Council of the Faculty of History of Vilnius University of 13 November 2023 (Minutes No. 170000-TP-4), as well as Resolution of the Research Affairs Committee of the Senate of Vilnius University of 17 November 2023 (Minutes No. 2023-11-20 (1.9 E) 11500-KT-492), the Senate of Vilnius University hereby decides:

to submit the following research papers to the 2023 competitions for the nominal prizes of the Lithuanian Academy of Sciences:

1. To submit the following research paper series to the competition for the nominal prize of Juozas Dalinkevičius (geosciences):

1.1. A research paper series by Dr Jurga Lazauskienė, Associate Professor at the Institute of Geosciences of the Faculty of Chemistry and Geosciences of Vilnius University, ‘The Tectonic, Geodynamic and Sedimentary Environment Evolution of the Baltic Region of the East European Craton’, which continues work in the fields of research of sedimentary basins and tectonic development of the Baltic region carried out by the academic Juozas Dalinkevičius (more detailed reasons for the nomination of the candidate are provided in the extract from the minutes of the e-meeting of the Council of the Faculty of Chemistry and Geosciences of Vilnius University of 11 November 2023 (Minutes No. 610000-TP-1));

1.2.
