**ON THE APPROVAL TO EXPAND THE BOUNDARIES OF VILNIUS UNIVERSITY  
TERRITORY BY TAKING OVER REAL ESTATE OF THE STATE LOCATED IN  
VILNIUS CITY MUNICIPALITY**

In accordance with Article 33(1)(7) of the Statute of Vilnius University, taking into account Resolution of the Government of the Republic of Lithuania No. 884 of 15 November 2023 “On the Approval to Reorganise the Public Establishment Vilnius College of Technology and Design by Integrating It Into the Public Establishment Vilniaus Kolegija”, Proposal from the Rector of Vilnius University No. RTK-34 of 4 April 2024 “On the Approval to Expand the Boundaries of Vilnius University Territory by Taking Over Real Estate of the State Located in Vilnius City Municipality” and Resolution of the Quality and Development Affairs Committee of Vilnius University Senate of 9 April 2024 (Minutes No. (1.10 E) 15900-KT-151), the Senate of Vilnius University

hereby decides:
