

RESOLUTION OF THE COUNCIL OF VILNIUS UNIVERSITY

ON THE AMENDMENT TO RESOLUTION OF THE COUNCIL OF VILNIUS UNIVERSITY NO. T-2018-2-1 OF 14 FEBRUARY 2018 "ON THE APPROVAL OF THE VILNIUS UNIVERSITY STRATEGIC PLAN FOR 2018–2020"

In accordance with Article 38(1)(11) of the Statute of Vilnius University, taking into account Proposal from the Rector of Vilnius University No. RTK-11 of 20 February 2020 "On the Amendment to Resolution of the Council of Vilnius University No. T-2018-2-1 of 14 February 2018 "On the Approval of the Vilnius University Strategic Plan for 2018–2020" and Resolution of the Senate of Vilnius University No. SPN-7 of 18 February 2020 "On the Approval of Draft Resolution of the Council of Vilnius University "On the Amendment to Resolution of the Council of Vilnius University No. T-2018-2-1 of 14 February 2018 "On the Approval of the Vilnius University Strategic Plan for 2018–2020", the Council of Vilnius University

hereby decides to amend the Vilnius University Strategic Plan for 2018–2020, approved by Resolution of the Council of Vilnius University No. T-2018-2-1 of 14 February 2018 "On the Approval of the Vilnius University Strategic Plan for 2018–2020":

1. to amend the performance indicator "Number of core academic units (faculties) holding a position higher than 300th in the QS World University Rankings" of the first strategic direction "Develop research at an international level" of the strategic priority "European University" and recast it as follows:

"The positions of study fields no lower than 300 in the QS Rankings";

2. to amend the performance indicator "Number of lecturers who have completed a programme to develop their educational competences" of the fourth strategic direction "Studies preparing for the global working environment" of the strategic priority "University Enhancing Lithuania" and recast it as follows:

"Number of lecturers who have completed a programme to develop their educational competences (result achievement monitoring of the strategic project No. 4.2)";
