



**RESOLUTION
OF THE SENATE
OF VILNIUS UNIVERSITY**

**ON THE AMENDMENT TO RESOLUTION OF THE SENATE OF VILNIUS
UNIVERSITY NO. SPN-29 OF 26 MAY 2020 “ON THE APPROVAL OF THE
COMPOSITION OF THE APPLICATION SELECTION COMMISSION OF THE
RESEARCH PROMOTION FUND OF VILNIUS UNIVERSITY”**

In accordance with Article 33(1)(26) of the Statute of Vilnius University and for the purpose of implementing the Regulations of the Research Promotion Fund of Vilnius University, approved by Resolution of the Senate of Vilnius University No. S-2015-2-10 of 17 February 2015 On the Approval of the Regulations of the Research Promotion Fund of Vilnius University” (wording of Resolution No. SPN-28 of 16 April 2019), and taking into account Resolution of the Research Affairs Committee of Vilnius University Senate of 17 May 2022 (Minutes No. (1.9 E) 11500-KT-184 of the meeting of the Research Affairs Committee of the Senate), the Senate of Vilnius University hereby decides:

to amend Item 1 of Resolution of the Senate of Vilnius University No. SPN-29 of 26 May 2020 “On the Approval of the Composition of the Application Selection Commission of the Research Promotion Fund of Vilnius University” and recast it as follows:

- 1.7. Prof. Dr Diana Cibulskienė, Professor at the Institute of Regional Development of Šiauliai Academy;
- 1.8. Assoc. Prof. Dr Laura Šukienė, Senior Researcher at the Institute of Regional Development of Šiauliai Academy;
- 1.9. Dr Rima Budvytė, Senior Researcher at the Institute of Biochemistry of the Life Sciences Center;
- 1.10. Assoc. Prof. Dr Arūnas Mickevičius, Associate Professor at the Faculty of Philosophy;
- 1.11. Prof. Dr Gintaras Valiulis, Senior Researcher at the Laser Research Center of the Faculty of Physics.”
