Purpose of the course unit

Aim of this course is to introduce students with main events and processes in Lithuanian history from the foundation of the Grand Duchy of Lithuania in the Middle Ages to the creation of two modern republics of Lithuania in 1918 and 1990, provide knowledge about inner and foreign and political actors and states that had enormous influence on Lithuanian history and develop their understanding of contemporary Lithuania and its geopolitical situation, critically interpret the dominant narratives of Lithuanian history.
