Kurso tikslas – supažindinti su įtakingais filosofais, kurie savo pažiūromis netelpa į nusistovėjusių politinių ideologijų ortodoksijos rėmus. Pasirinkti autoriai leidžia pamatyti neišnaudotas požiūrio į liberaliąją demokratiją galimybes. Jų pasirinkimą lemia du pagrindiniai veiksniai: iškritimas iš nusistovėjusios politinės ortodoksijos rėmų ir dabartinę Vakarų liberaliąją demokratiją suprasti padedančios idėjos. Kursą branduolį formuoja Leo Strausso, Carlo Schmitto ir Alexandre Kojève darbai. Kiti autoriai jiems padarė įtaką, diskutavo arba išvystė jų idėjas.

Kurso apimtis – 16 seminarų.
