Purpose of the course unit		
<p>This course is designed to equip students with a comprehensive understanding of development cooperation, both on a global scale and within the Baltics. It delves into the core principles, the latest trends, key actors, and methods in the field. Beyond knowledge acquisition, it fosters critical thinking abilities to assess and reflect upon existing theories and practical approaches. Students will gain the skill needed to apply conceptual knowledge to real-world development cooperation tasks, including crafting project concept notes and formulating evidence-based policy recommendations for decision-makers.</p> <p>This course aims to develop subject specific competences, such as, capacity to define key concepts of development cooperation, bridge the gap between theory and practice, independently analyse and evaluate development cooperation policies, processes, and initiatives. Students will also develop proficiency in applying an evidence-based approach to both development cooperation policymaking and real-world project concept note development. In addition, this course is developing certain generic competencies: effective communication of ideas in writing and orally with context-sensitive approach, ability to work in groups and individually.</p>
