Purpose of the course unit

This course is designed to provide knowledge about the history of Jagiellonian Europe (the Grand Duchy of Lithuania, the Kingdom of Poland, the Kingdom of Hungary, and the Kingdom of Bohemia); to introduce the historical, political, and civilizational issues of the Central and Eastern European region; to understand how medieval political unions functioned; to be able to compare different forms of medieval unions, and to analyse and interpret literature and sources.

In this course, students will develop both theoretical skills (understanding political history research and methods, analysing social processes) and practical skills (formulating and presenting possible solutions to problems using collected information and appropriate methods). Students will also gain research and applied knowledge. By the end of the course, students should be able to analyse problems in the history of Central and Eastern Europe in the early modern period on their own and present a chosen topic in a clear and well-structured way, both in writing and orally.

Active participation in the seminars	30 %	During each seminar	10–9 points: Active participation in discussions; excellent knowledge and understanding of the topic under discussion; answers questions; independently formulates problems and suggests possible solutions; provides critical remarks. 8–7 points: Participation in discussions; good knowledge and understanding of the topic under discussion; raises problem-based questions; answers questions; completion of most seminar tasks. 6–5 points: Limited knowledge of the topic under discussion; incomplete seminar work (assignments); superficial understanding of the seminar topic. 4–1 points: Seminar material not mastered; little to no participation in discussions, or more than one-third of seminars missed.
Written assignment and its presentation (15 min.)	20 %	At the scheduled time during the semester	Structure and scope of the written assignment: the structure of the presentation is clear and logical, including all required parts (introduction presenting the topic, objectives, tasks, and problem; presentation of the content with analysis and interpretation of empirical material; conclusions). The presentation fits the required length (2 points). Analysis and conclusions: the analysis is very thorough; the conclusions are well-founded and formulated on the basis of collected empirical material (6 points). If the analysis is carried out but not comprehensive, and conclusions are not always well-founded, 4 points. Superficial analysis – 2 points. Academic style and research culture: appropriate vocabulary is used during the presentation; sources are properly selected and interpreted; formulations and style meet the requirements of an academic presentation (2 points). Grade of 0 points is given if the written assignment and presentation are not prepared and delivered.
