## **Annotation**

In this course, we will trace the main developments of post-Soviet Lithuania literature. We will read the literary works written in the 1980s till present day and address such topics as: How has Lithuanian literary landscape changed after the collapse of Soviet Union? What were the major literary hopes and challenges? How does literary society relate to and reflect its dramatic past? What characterizes post-Soviet Lithuanian literature? We will apply theoretical concepts such as trauma, postmodernism, nostalgia, to interpret and analyze the texts.

## Purpose of the course unit: programme competences to be developed

The course will contribute to students' better understanding of the development of Lithuanian literature during the 20<sup>th</sup>-21<sup>st</sup> centuries. Questions such as art and ideology, censorship, national allegory, innovative literary techniques, perception of postmodernism will be addressed either by focusing on Lithuania's cultural and historical context or in a comparative perspective of Eastern European literary tendencies which will represent Lithuanian literature as an integral part of literary map of the region.

Participation in seminars (students read literature before the class, participate in discussions, complete seminar assignments)	20 %	during seminars	2 points: actively participates in all seminars, responds appropriately to questions, formulates problematic and accurate questions to audience, properly argues text analysis problems;  1 point: misses up to 3 seminars, participates in the discussion, answers the questions correctly, properly performs practical tasks;  0 points: does not prepare for seminars, hardly participates in the discussion.

Exam consists of two types of questions:    1st   question:     knowledge   of   literary     development,   cultural     contexts,   authors   and   their     works,   themes,   aesthetic     preferences;	60 %	at the end of semester	Each question is worthy 30%.  3 points: understands the historical and cultural contexts of the era very well; excellently demonstrates knowledge of the development of literature; knows very well the artistic programs of the main authors, knows their works and aesthetics very well; noted connections with European literature;  2 points: correctly presents the historical and cultural contexts of the era, is able to describe the development of literature, knows authors and their works but presents the knowledge sporadically;  1 point: the knowledge about historical and cultural contexts of the era is partially revealed; knowledge of authors, their works, and their artistic programs is sporicidal.  0 points: question is not answered or does not meet the criteria.

3 points: excellent knowledge of the authors and works, excellent knowledge of the context; the problematic of the work, its originality of representation is insightfully discussed, analysis based on quotations from the work;

2 points: good knowledge of the authors and works, brief but correct knowledge of the context, problematic of the works is discuss in correct but somewhat general way; quotations are missing or redundant;

1 point: knowledge of the authors and works is inaccurate, no critical approach to the text, analysis of the text is too general.

0 points: question is not answered or does not meet the criteria.
