Course review: the principal goal of the course is to introduce the Asia-Pacific region from the political point of view, i.e. its principal states' political systems, relations among themselves as well as with outside actors. The course examines not only the Western part of the Pacific littoral (Northeast and Southeast Asia), but also the South Asian region (Indian subcontinent) and the most important "peripheral" countries.

Assessment:

- seminar work -30%;
- research paper (12 pt. Times New Roman, 1,5 space; maximum 10 pages; minimum 10 sources of which minimum 3 books; due mid-December; up to 3000 words of main text Introduction to Conclusion inclusive; within-text referencing is compulsory, i.e. a mere literature list is not enough) 30%;
- exam (online, open-book, open-question; January) -40%.

The course is successfully finished only by those who get positive grade (5 or more) for both their research paper and exam, and attended not less than 80% of seminars (missed no more than 3).

Students might expect to answer short questions in writing based on the readings for every seminar.

All cases of academic dishonesty, including "copy-paste"-kind plagiarism during the examination from academic sources or notes prepared in advance, lead to severe repercussions starting with course failure. The usage of artificial intelligence-based content for research paper or examination is also considered academically dishonest.

<u>Literature</u>: all literature is available in electronic format. During preparations for the classes, research paper and exams the students are induced to use any additional material of academic value.

Slight changes to the syllabus might appear throughout the course.
