Subject annotation

The main aim of the course is to analyse the most important legal acts and codes of the 15th-16th centuries (land and regional privileges, Lithuanian statutes, Sejm's constitutions of the Polish-Lithuanian Commonwealth), which provide an insight into the legal culture of the nobility of the GDL of that period.

The main objectives of the course (topics covered)

- Deepening the concept of the GDL as a constituent state by analysing the nature of regional privileges and the scope of their operation;
- The development of the legal norms of the GDL and their impact on the development of noble democracy through the analysis of sources reflecting regional characteristics (petitions and instructions to the Sejm);
- Analysis of the reciprocal effects of land and regional privileges;
- Analysis of the relationship between the elements of customary law preserved in the law of the GDL and the modernisation of state law;
- Analysis of the development of the organisation of the judicial institutions of the nobility;
- Analysis of the Lithuanian statutes as an original of the legislative culture and as the reception of law's norms from the Polish kingdom;
- Analysis of the impact of legal innovations of the Polish-Lithuanian Commonwealth on the legal consciousness of the GDL's nobility;
- Analysis of the litigation customs of the GDL's nobility;
- Heuristic strategies in search of historical sources depicting the everyday legal culture of the nobility;
- The search for a place of the phenomenon of the GDL law in the history of European jurisprudence during the Renaissance;
- Issues of the discourse of the legal culture of the nobility of the Grand Duchy of Lithuania in the 16th century polemical literature.
