

RESOLUTION OF THE SENATE OF VILNIUS UNIVERSITY

ON THE PROPOSAL OF CANDIDATES FOR THE 2025 ELECTION OF MEMBERS OF THE YOUNG ACADEMY OF THE LITHUANIAN ACADEMY OF SCIENCES
