

RESOLUTION OF THE SENATE OF VILNIUS UNIVERSITY

ON THE PROPOSAL OF CANDIDATES FOR THE 2023 ELECTION OF MEMBERS OF THE YOUNG ACADEMY OF THE LITHUANIAN ACADEMY OF SCIENCES

In accordance with Article 33(1)(32) of the Statute of Vilnius University, Item 5 of the Description of the Organisation and Procedure for the Election of Members of the Young Academy of the Lithuanian Academy of Sciences, approved by Resolution of the Presidium of the Lithuanian Academy of Sciences No. 36 of 9 October 2018 (as subsequently amended), Resolution of the Research Affairs Committee of the Senate of Vilnius University (Minutes No. (1.9 E) 11500-KT-379 of 26 September 2023) and taking into account the reasons set out in Minutes of the Council of the Faculty of Chemistry and Geosciences of Vilnius University of 14 September 2023 (Minutes No. 610000-TP-7), Minutes of the Council of the Faculty of Philosophy of Vilnius University of 13 September 2023 (Minutes No. 250000-TP-11), Minutes of the Council of the Faculty of Physics of Vilnius University of 20 September 2023 (Minutes No. (1.2. E) 120000-TPN-25), and Minutes of the Council of the Faculty of Mathematics and Informatics of Vilnius University of 22 September 2023 (Minutes No. (1.5 E) 110000-TPN-22), as well having assessed the documents submitted by the candidates, the Senate of Vilnius University hereby decides:
