

RESOLUTION OF THE SENATE OF VILNIUS UNIVERSITY

ON THE AMENDMENT TO RESOLUTION OF THE SENATE OF VILNIUS UNIVERSITY NO. SPN-27 OF 16 APRIL 2024 "ON CHANGING THE NAME OF THE SECOND CYCLE STUDY PROGRAMME 'PUBLIC ECONOMIC POLICY' OF THE FACULTY OF ECONOMICS AND BUSINESS ADMINISTRATION OF VILNIUS UNIVERSITY"

In accordance with Article 33(1)(10) of the Statute of Vilnius University, Item 53 of the Rules of Procedure of the Senate of Vilnius University, approved by Resolution of the Senate of Vilnius University No. S-2014-6-1 of 9 September 2014 "On the Approval of the Rules of Procedure of the Senate of Vilnius University" (as subsequently amended), Items 40 and 41 of the Description of the Procedure for the Development, Implementation and Improvement of Study Programmes at Vilnius University approved by Resolution of the Senate of Vilnius University No. SPN-58 of 18 October 2022 "On the Approval of the Description of the Procedure for the Development, Implementation and Improvement of Study Programmes at Vilnius University and on the Repeal of Resolution of the Commission of the Senate of Vilnius University No. SK-2012 of 18 October 2012 "On the Criteria for Evaluating the Study Programmes Intended to be Implemented at Vilnius University", taking into account Proposal from the Rector of Vilnius University No. RTK-27 of 2 April 2024 "On Changing the Name of the Second Cycle Study Programme 'Public Economic Policy' of the Faculty of Economics and Business Administration of Vilnius University", Resolution of the Council of the Faculty of Economics and Business Administration of Vilnius University of 12 March 2024, and Resolution of the Studies Affairs Committee of Vilnius University Senate of 9 April 2024 (Minutes No. (1.8 E) 11500-KT-150), the Senate of Vilnius University
