**ON THE AMENDMENT TO RESOLUTION OF THE SENATE OF VILNIUS
UNIVERSITY NO. SPN-56 OF 18 OCTOBER 2022 “ON THE ESTABLISHMENT OF THE
COMMISSION FOR GRANTING PEDAGOGICAL TITLES AT VILNIUS UNIVERSITY
AND ON THE REPEAL OF CERTAIN RESOLUTIONS OF THE SENATE AND A
SENATE COMMISSION OF VILNIUS UNIVERSITY”**

In accordance with Articles 33(1)(23) and 33(1)(32) of the Statute of Vilnius University, Item 13 of the Description of the Procedure for Granting the Pedagogical Titles of Professor and Associate Professor at Vilnius University, approved by Resolution of the Senate of Vilnius University No. S-2011-7-1 of 25 October 2011 “On the Procedure for Granting Pedagogical Titles at Vilnius University” (wording approved by Resolution of the Senate of Vilnius University No. SPN-63 of 24 September 2024), and taking into account the Proposal of the Rector of Vilnius University No. RTK-50 of 17 September 2025 “On the Amendment of Resolution of the Senate of Vilnius University No. SPN-56 of 18 October 2022 “On the Establishment of the Commission for Granting Pedagogical Titles at Vilnius University and on the Repeal of Certain Resolutions of the Senate and a Senate Commission of Vilnius University” and Resolution of the Quality and Development Affairs Committee of the Senate of Vilnius University of 16 September 2025 (Minutes No. (1.10 E) 15900-KT-419), the Senate of Vilnius University hereby decides:

to amend Resolution of the Senate of Vilnius University No. SPN-56 of 18 October 2022 “On the Establishment of the Commission for Granting Pedagogical Titles at Vilnius University and on the Repeal of Certain Resolutions of the Senate and a Senate Commission of Vilnius University” (with subsequent amendments) Item 1 to read as follows:

1. to establish the Commission for Awarding Pedagogical Titles at Vilnius University:
 - 1.1. Dr Valdas Jaskūnas, Pro-Rector for Studies, head of the Commission;
 - 1.2. Judita Barkauskienė, Head of the Human Resources Division of the Central Administration;
 - 1.3. Prof. Dr Arūnas Poviliūnas, Professor at the Institute of Sociology and Social Work of the Faculty of Philosophy;
 - 1.4. Prof. Dr Ramūnas Garunkštis, Professor at the Institute of Mathematics of the Faculty of Mathematics and Informatics;
 - 1.5. Dr Loreta Skurvydaitė, Dean of the Faculty of History;
 - 1.6. Prof. Dr Aidas Matijošius, Dean of the Faculty of Physics;
 - 1.7. a student representative delegated by Vilnius University Students’ Representation.”
