

RESOLUTION OF THE COUNCIL OF VILNIUS UNIVERSITY

ON THE APPROVAL TO EXPAND THE BOUNDARIES OF VILNIUS UNIVERSITY TERRITORY

No. TPN-18 of 26 November 2025

In accordance with Articles 3(3) and 38(1)(9) of the Statute of Vilnius University, taking into account Resolution of the Council of Vilnius City Municipality No. 1-RTK-711472 of 22 October 2025 "On the Transferring of Ownership of Real Estate Located at M. K. Čiurlionio g. 110B, 112A, and 114, Ašmenos g. 8, and Vokiečių g. 10-27, Vilnius, to State Ownership", Resolution of the Senate of Vilnius University No. SPN-48 of 18 November 2025 "On the Approval to Expand the Boundaries of Vilnius University Territory", and Proposal from the Rector of Vilnius University No. RTK-71of 17 November 2025 "On the Approval to Expand the Boundaries of Vilnius University Territory", and in order to meet the increasing infrastructure needs of Vilnius University community for carrying out academic activities, the Council of Vilnius University

hereby decides to approve the expansion of boundaries of Vilnius University territory by taking over the following:

1. real estate, currently held by Vilnius City Municipality by the right of ownership and being transferred to State ownership, to manage, use, and dispose of it for the period of 99 years under the trust agreement:
